Majestic Fire Apparel, Inc. does not alter, add, or utilize the use of PFAS chemicals in our processes for the distribution of general-purpose protective gloves.

We are committed to providing high-quality products through our carefully selected network of trusted suppliers and partners.

Our suppliers select barrier fabrics, which are purchased from textile manufacturers for incorporation into the manufacture of general-purpose protective gloves.

Based on the information provided by these barrier fabric suppliers, their fabrics contain polymer compounds with some fabrics also including durable water-repellent finishes, which fall under the definition of PFAS chemicals.

These polymer compounds and finishes are critical to the wearer's general safety by providing essential protection while reducing the risk from extremely dangerous exposures, which includes limited protection from exposure to particulates while enhancing wear comfort by managing heat and moisture.
